Waiver, Release, Indemnity & Hold Harmless
Glenbard Township High School District 87

We, the undersigned, are the parents/guardians of _____ (the "Student"), a student in Glenbard _____ High School in Glenbard Township High School District 87 (the "District"). The Student is a member of the _____ Team (the "Team") and will participate in the Team practices, meets and other Team events (the "Events").

We hereby give our full permission for the Student to travel to and from the Team Events in whatever manner we or the Student arranges. We understand that this is a voluntary activity, involving a more substantial risk of severe injury or death to the Student than is associated with traditional school activities. We understand and agree that the District has no responsibility whatsoever for providing transportation to or from Events, and we assume full responsibility for making the arrangements for the Student's transportation and for the transportation itself.

We further understand and agree that the District has no responsibility whatsoever for supervising the Student's activities before or after the Actual Event, including without limitation transportation departure, arrival or any other activity occurring before or after the Actual Event (the "Non-Event Activities"), and that the District will not provide supervision of the Non-Event Activities. Supervision is provided by the Team's coach(es) only during the Actual Event, which is the period beginning at the official start of the Event and ending immediately upon the official conclusion of the Event. We understand that we are solely responsible for the Student and all Non-Event Activities.

For and in consideration of the District permitting the Team to exist as a sport or emerging sport of the District in which the Student may participate, we hereby waive, release and warrant that we shall not bring any claim, by lawsuit or otherwise, against the District, its Board of Education or its members, officers, employees, agents and volunteers directly or on behalf of the Student or any other person in connection with the Student's travel to or from any Event or in connection with any Non-Event Activities. By signing below, the Student has joined in this agreement, commitment, waiver, release, and acceptance of responsibility.

We further agree to indemnify and hold harmless the District, its Board of Education and its members, officers, employees, agents and volunteers (the "Indemnitees") from any claim, loss, or expense whatsoever, including without limitation reasonable attorneys' fees, brought against or suffered by any of the Indemnitees due to any injury, including death, or loss suffered by the Student or us in connection with the Student's transportation or Non-Event Activities under this agreement, or as a result of the Student's acts or omissions in connection with such transportation or activities, or arising out of a claim directly or indirectly related to such transportation or activities brought by any other person and arising out of the Student's acts or omissions.
